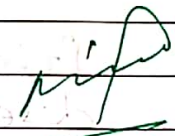

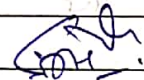

 discuss regarding different academic and
 developmental issues of the college.

Vide notification no 3783 dt. 24/07/2020, the
 previous Governing Body has been
 superseded and the new Governing Body
 with Sub-Collector, Athmalik as
 President, Governing Body with Principal-cum-

Secretary, Janata College Banda conducted the first meeting of the Governing Body on 12.03.2020.

After careful deliberations the following resolutions were adopted on different developmental and academic issues of the College.

01. Disengagement of contractual teachers in the summer vacation:-

It was resolved that the Principal shall take appropriate steps to disengage the contractual teaching members of the College in the summer vacation. Care should be taken to safeguard the academic interests of the students.

02. Appointment of Contracted/Guest faculties in the new session-2021-22.

Resolved that the Principal shall take appropriate steps for engagement of contractual/guest faculties in the new academic session in subjects like History, Physics, Zoology and Chemistry.

03. Increase of admission fee and re-admission fee in +2 1st yr. Arts and Science and +3 Arts 1st year.

Resolved that Financial status of the College has to be increased in order to provide better

infrastructure and facilities. Hence, it was decided that admission and re-admission fees of +2 1st yr. Arts and Science and +3 1st year Arts shall increase by Rs. 500.00 each per student from the new academic session.

4. Purchase of books and equipments: (+3 Degree)

Resolved that the Principal shall take proper care to purchase library books as per CBCS pattern from the fund provided by OHEPEE (World Bank) which has been already approved by the SPD, OHEPEE.

Principal is also requested to take steps for purchase of laboratory equipments and chemicals for the +3 classes from the fund provided by OHEPEE (World Bank).

It is also advised that out of Rs 2000000.00 sanctioned to the College in the current year and the unutilized fund of previous year shall be spent following strict guideline of the OHEPEE (World Bank) project.

5. Purchase of books and equipments, (+2 classes)

Resolved that the Principal shall take steps for purchase of library books and equipments for the laboratory out of fund available in the College.

06. To provide book bank facility:

Resolved that the Principal shall take proper care for introducing Bank Bank facility to the students from the current academic session.

07. Mergent of +3 Arts and Science Cash book from the current session (F.Y.-2020-21)

Resolved that in order to avoid difficulties in CAPA and for better financial transparency, it is directed to the Principal to merge the +3 Arts and Science cash book. Separate passbook may be continued as before. The account books may be given direction accordingly.

08. Repair and renovation work of Principal's office.

Resolved that the office building of the Principal's office is in a dilapidated condition. Hence, Rs 100,000/- may be spent for repairing work and renovation work. A detail estimate of expenditure may be submitted for P.B. approval by the President, Governing Body.

09. Resolved that for safety of all online transactions only one account for +2 and One account for +3 transactions may be used. The Principal can take suitable steps for better management of online transaction.

10. Resolved that the Principal will take proper steps for the expenditure of Rs 1000000 received from the

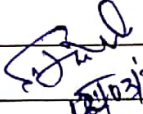
Higher Education Department as infrastructure grant as per the standard guideline available from the DHE.

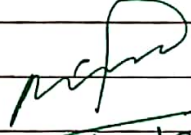
11. World Bank Project.

Resolved that the Principal shall take proper care to implement different essentials of World Bank Project. Care should also be taken for timely spending of the non-civil fund sanctioned by the OHEPEE.
