Meeting of the Governing Body of Janata College, Boinda was called to discuss different development related issues of the college in the presence of S.J. Lalit Mohan Behera, O.A.S. (I), Sub-Collector, Athmallek and President, Governing Body with Principal cum Secretary, Janata College, Boinda. The meeting was held observing all the Covid-19 guidelines. After careful deliberations, the following resolutions were adopted unanimously.

01. The G.B. finds that the old classroom building is in a dilapidated condition. As it is no longer safe for class room purpose, the G.B. approves the steps taken by the Principal for construction of a new class room building according to the plan and estimate already approved and accepted by the construction committee of the college. The Principal is directed to utilize the infrastructure grant received from DHE (Rs 100000.00) and rest of the amount from the development fund of the college.

02. The G.B. resolves that the new class room building shall be as per the P.W.D. plan and estimate and construction work shall be executed under the supervision of the Construction Committee under chairmanship of the Principal.

03. The G.B. resolves that the post of Librarian which is lying vacant due to superannuation of the librarian may be filled up by re-engaging Lombardan Pradhan on contractual basis for the smooth management of the college library.

The G.B. also finds that the post of peon has been lying vacant as in the meantime 05 no. of peons have been retired or deceased. The G.B. feels the necessity of appointing a peon and on temporary (Contractual) engagement. At the same time Smt Janagewan

Pradhan, who has been working as Peon-in-lieu of watchman may be shifted to day duty and a watchman may be engaged on temporary contractual basis for safe upkeep of the college property. Mune Rana, who is now engaged on daily basis may be appointed on contractual basis as per.

09. The G.B. resolves that out of the sum deposited as compensation for boundary work RS 720000.00 may be utilized for the construction of a gate/entrance of the college.

05. The G.B. resolves that E.P.F. account of Sunejanta Sahoo, DEO working on contractual employee may be applied and e.p.f. may be allowed to him as he has already completed 07 years of service in the college to the best satisfaction of the authority.

06. The G.B. resolves that the appointment of (i) Arundhati Sahoo, Lect in IT, (ii) Sushree Adimata Pradhan, Lect in Economics appointed in place of late Hrudananda Pradhan in continuity and Sudhakar Sahoo, Lect in Political Science may be regularized from the initial date of appointment. The Principal may take suitable steps for the regularization of their posts at Government level to give them benefit of Grant in Aid from the Government.

After careful deliberations on the above points, the Governing Body

jointly attended by the President, Governing Body and Principal-cum-Secretary of the College unanimously adopt the above resolutions.
