Meeting of the Governing Body of Janata College, Boinda was held to discuss different development related issues of the college in the presence of President, Governing Body and Principal-cum-Secretary.

At the outset, the resolution of previous meeting was read and approved by the President, Governing Body.

The meeting was held observing all Covid-19 guidelines.

After careful deliberations, the following resolutions were adopted by the Governing Body.

01. Budget Approval : Budget for the session 2021-22 was presented by Account Bursar Sri Asit Kumar Jena and unanimously approved by the President and the Principal of the college.

02. Resolved that after completion of the new class room, the old academic building which was constructed in 1978, which is in a dilapidated condition, must be demolished. The Principal of the college is directed to obtain the permission of the Engineering department like PWD or RD after examining the present condition of the building. Accordingly the Principal may take suitable steps for demolition of the old building at the earliest.
03. Resolved that the principal may initiate steps to purchase equipments (for Science lab) and text books as required for the 12 students.
04. Resolved that the Principal may initiate steps for construction of a cycle stand. Salvaged materials like asbestos sheet, beam and bricks may be used for the cycle stand. A sum of Rs 20000.00 (Two lakhs) is sanctioned towards labour cost.
05. Resolved that the Principal Office and Establishment section of the College building is in a dilapidated condition. The Principal is sanctioned Rs 40000.00 for construction / renovation of the building.
06. Resolved that a sum of Rs 10000.00 (Rupee ten lakhs only) out of the development fund of the college may be deposited every year as recurrent / Fixed deposit.
07. Resolved that the Principal may initiate steps for the utilization of the SAMS money after obtaining permission of appropriate authority.
08. Resolved that, after ROR is obtained by the College, the Principal may initiate steps for the construction of an entrance gate.
09. Resolved that, as there is dire need of a reading room for the students, the Principal may initiate steps for converting Hall No-11 to Reading room by shifting the class to newly constructed class room. A sum of Rs 20000.

may be spent. If the fund from SAMS is released by the Govt. or permission is granted for withdrawal by the Govt., the amount may be spent for construction of a library hall in the college.

09. Resolved that the Principal may initiate steps for the appointment of the following posts on contractual basis.

(i) Night Watchman - 01

(ii) Peon - 01 nos.

(iii) Demonstrator - 02 nos

(iv) Librarian - 01 no

(v) PET - 01 no

(vi) DBO - 01 NO.

The above appointments shall be made purely on contractual basis and may be terminable at any time showing no reason there of.

10. Resolved that, Sri Achyuta Mahakur, Lecturer in Botany has been framed charge under proceedings held according to G.B. Resolution No-32, Dt. 04.01.2013.

The G.B. directs the Principal to go through the details of Sri Achyuta Mahakur and initiate action to terminate him.

10. Resolved that a sum of Rs 3500000.00 (Three Lacs fifty-thousand) may be spent for two numbers of smart class room.

12. Rationalization of Management salary: Resolved that in order to solve the disparity in salary of Management regular staff and Management contractual staff, the G.B. decides as follows and directs the Principal to follow it from the month of February. The salary is fixed notionally from the month of February with effect from 2014.

(i) The salary is notionally fixed at Rs 10000.00 (Rupees Ten Thousand Only) for all management regular staff w.e.f. February, 2014.

- (ii) Every completed year of service after 2014, the employee shall be entitled to receive an increment of 03% to the total of the previous year.
- (iii) Priyabrata Mohanty, Management regular staff is allowed e.p.f. benefit from February 2022 or the date from which his e.p.f. account is activated.
- (iv) The G.B. decides that the service of Sandhyarani Roul, Lect in Philosophy/Logic may be regularised from the date of her initial appointment.
- (v) The G.B. decides that the salary of all lecturers appointed in the College Contractual staff are allowed to get an increase of Rs 500.00 (Rupees five hundred only)
- (vi) The G.B. empowers the Principal to disengage the contractual staff whenever workload is not justified
13. The G.B. resolves that the admission fees and re-admission fees of students may be increased by 3% every year in order to meet the increasing expenditure of the College regarding salary.
14. The G.B. resolves that Niroja Nalini Mohanty was appointed as Lab Assistant initially, but as Govt. guideline changed subsequently, her post could not be regularised. As a result, the Governing Body in their meeting (Res-02 Dt. 10.06.2016) had instructed the Principal to take appropriate action to treat her as Non-Government Librarian from the date of her appointment or from the date from which Non-Graduate Librarian post is eligible in the College.

But, the Governing Body in their meeting had erroneously mentioned not mentioned the expression "from the date of her appointment or from the date of admissibility of her post as Non-Graduate Librarian."

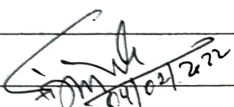
Hence, the G.B. resolves that she may be given the benefit of Non-Graduate Librarian from the date of her appointment or from

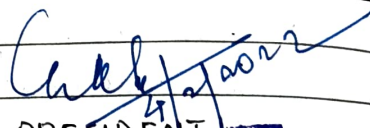
the date from which non-graduate librarian post is admissible in the College.

The G.B. also agrees to enhance salary of Niorja Nalini Mohanty by Rs 2000/- as ex-gratia on account of her long years of service to the institution.

The G.B. directs the Principal to take appropriate step for the regularisation of her post for approval.

The meeting was adjourned with vote of thanks by the Principal.
